Public Policy

Look no further than our own Minnesota Pine, Fall 2012, for information about voter ID and the marriage amendment. Minnesota's State Public Policy VP, Char Kahler, has written definitive articles on both topics: "Encourage Rather than Discourage Voting," and "Marriage Amendment" --MN Cities Take a Stand. As you may or may not know, AAUW, both national and state, have presented the Vote NO position on both these amendments. Regardless of our personal positions, we need to understand the impact that these amendments can have on individual citizens.

David Schultz, Professor of Public Policy at Hamline University has said this: "Voter fraud at the polls is an insignificant aspect of American elections. There is absolutely no evidence that voter impersonation fraud has affected the outcome of any recent elections in the U.S

In the same issue, Karen Rowley and Carrie D'Andrea have provided sources to examine the Affordable Care Act. While the need for improving health care and health care systems is not disputed, the way to do so is subject to debate.

AAUW continues to be in the forefront on issues of national concern. Public Policy and Government Relations Director, Lisa Maatz was in the 'thick of things" at both national conventions. She spent time in both convention halls talking with delegates, party power brokers, and others about our policy priorities, and the nonpartisan campaign to educate and turnout voters--"It's My Vote: I Will Be Heard." No group is advocating for women's issues more than AAUW!

The National Campaign to Prevent Teen and Unplanned Pregnancy has found that 72 percent of adults and teens believe that policymakers who are opposed to abortion should support access to birth control.

Did you know that 10 million girls are married every year before the age of 18? The United Nations Population Fund is working with governments around the world to enact and implement laws prohibiting child marriages. In the U.S. House of Representatives there is legislation which proposes to end child marriages and to connect international assistance programs to such legislation. Both the House and the Senate (which has passed legislation to end child marriage) have declared these marriages to be a human rights abuse under U.S. law.

AAUW Board met at Christ Episcopal Church. Present were Kari Bain, DedaRae Graber, Sue Grove, Evelyn Guentzel, Barb Hunter, Kathy Kester, Dorothy Krob, Yesenia Mendoza, Ruth Monson and Mary Kay Wilson.

Secretary's report was reviewed and approved.

The Treasurer's report was reviewed and approved. Mary Kay reported that the Pizza Ranch fundraiser brought in \$483.94 and the Board agreed that this would be a good way to raise funds in the future.

A gift of \$500 was received from Sandy Jarvis, who received an AAUW scholarship in 1988. Sandy returned the money to AAUW with her thanks, with the intention that the money be used for future scholarships.

The 2012-13 budget was approved. The budget, published in the May newsletter, was approved with one small change: "space rental/banquet" was increased to \$200 in order to keep the cost of the spring banquet as low as possible for the members.

Yesenia and Kari reported on this year's program. Kari will publish the updated program schedule in the October newsletter.

Barb gave a membership update. She said that there are still 17 members from last year that have not paid dues. She requests that members inform her of address/email/phone number changes. Sue reported that the new member wine and cheese social went very well.

<u>New Census Data Shows No Progress in</u> <u>Closing Wage Gap</u>

This month the U.S. Census Bureau released 2011 income data revealing that women continue to earn only 77 cents, on average, to every dollar men earn, virtually unchanged over the last decade. The numbers are worse for black and Hispanic women, who make an average of 64 cents and an average of 55 cents, respectively, for every dollar paid to white, non-Hispanic men.

AAUW believes that equal pay for equal work is a simple matter of justice for women and as such has been at the forefront of research and advocacy on pay equity for many decades. The 2011 Census data demonstrates the need for Congress to pass the Paycheck Fairness Act – use AAUW's Two-Minute Activist Network to urge your elected officials to support the Paycheck Fairness Act and help us achieve pay equity nationwide.
